## **1. INTRODUCTION**

- 1.1. In accordance with Standing Order A.4, the North London Waste Authority schedules a number of ordinary meetings each year, plus extraordinary meetings which are called if there are important urgent matters requiring the decision of the full Authority.
- 1.2. The meeting dates are proposed on the basis of an even spread throughout the year but taking account of statutory deadlines imposed in relation to various Authority functions as detailed below.
- 1.3. A request has been made for amendments to some of the proposed dates on the main agenda as a reasonable adjustment. There is limited ability to move meeting dates as officers seek to avoid clashes with party conferences, religious festivals and the London Councils Transport and Environment Committee, while meeting statutory deadlines. However, two potential changes have been identified.

- 2.1. Members are asked to note that the Levy must be notified to boroughs before 15 February 2027 which requires the Authority to meet prior to that date, but late enough to allow officers to prepare the budgetary information needed for Members to make the decision.
